The Regd. Office of "ASSORTED INTERNATIONAL ASSISTANCE CENTRE " (AIAC) shall be situated at Ananda Nagar, Bolangir Town, P.O. Rajendra College, Dist. Bolangir-767002, ODISHA. And it may be extended to any place in India passing resolution in the executive body of the Trust to that effect.

AIMS AND OBJECTIVES:

The Trust shall utilize funds/grants received in cash or kinds, moveable and immovable properties for the work of the Trust "ASSORTED INTERNATIONAL ASSISTANCE CENTRE" (AIAC) from well wishers for the following objectives and purposes.

1. To afford relief for people in distress due to natural calamities, accident, earthquake, flood, famine and epidemic through disaster preparedness and management programmes.
2. To provide food shelter, clothing, medical care and education for the needy and socially excluded unnatural disasters.
3. Take the different development programmes such as water supply, road construction, sanitation, health awareness etc.
4. To take a program in a net based system.
5. Our trust is formulated on innovative career path programme, which is designed to provide platform for meeting the triple objective of
